Memorial Day was always meant to be more than just the official kick-off for summer, a day to hang out at the beach, or bar-b-que with friends. On Memorial Day, we should stop and reflect on the lives lost defending our nation. **#LemonAID** gives parents an opportunity to teach their children about the cost of our freedoms and families a fun way to honor these fallen soldiers and their families!

Families purchase t-shirts and register their stand. They host a **#LemonAID** stand anywhere over Memorial Day Weekend...in their driveway, a local park, shopping center, or even a place of business! We send LemonAID Stands marketing materials and participants collect funds from **#LemonAID** stand patrons. At the end of Memorial Day Weekend, the students donate their earnings online to Believe With Me!

Freedom 4 Miler

A yearly race held to honor four local families of fallen soldiers. Dozens of Gold Star Families attend and are given so much love and encouragement from race participants. While this event is designed as a fundraiser, the parade for Gold Star Families and the dinner event on July 3rd preceding the race, as well as the event itself, are all designed to make sure our Gold Star Families have something to truly celebrate on July 4th.

Outreach

Believe With Me provided gas cards, gift cards to restaurants and school supplies for the widows of fallen soldiers headed back to school. Many of our widows need secondary education or job training for vocational skills and with a little help from us, they are able to make ends meet as they complete their education.

An American Gold Star Christmas

Grateful Americans from all across the country sponsor the Christmas gifts of Gold Star Children. Our Student Ambassadors and volunteers wrap, pack and ship gifts to children of fallen soldiers. Not only to we send so much love and support to each of our Gold Star families, but our extensive student volunteer base learn the cost of their every freedom and opportunity as they read their stories of the families they are wrapping gifts for. Freedom has a face when our volunteers work to help us bring hope to our Gold Star Families.

The House That Love Built

A project where Believe With Me restores a family of a fallen soldier to home ownership after the death of their son/daughter and the pursuing catastrophic financial loss. The House That Love Built has so far included: a complete restoration and furnishing of the Schumann home in honor of SPC Jordan Schumann, KIA 07.05.11. Believe With Me purchased, renovated and furnished a home for the Vaughn Family, parents of SOC Aaron Vaughn KIA 08.06.11. We fully furnished a new home given to Lisa Heintz, proud parent of SrA Joshua Reinwasser, DOD 11/11/18. In July of 2020, Believe With Me, in partnership with GL Homes and the City of Port St Lucie will give a fully furnished new home to the Sandberg Family. These projects rely heavily on the support of our grassroots fundraising and incorporate veterans, Gold Star Families as well as our Student Ambassadors to complete the work. Each house is given over in a full ceremony including massive community support and police escort.

Benevolence

As families come under our umbrella of care through the Gold Star Christmas program, we are then able to meet basic financial obligations for them when they are unable to fulfill their budgetary requirements. Mortgage payment, rent, electric bills, groceries, gas, tuition, uniforms, sports fees, and other monetary shortfalls can be paid through our benevolence fund when applicants request and meet requirements pending a board decision.

Student Ambassador Program

Students who seek to serve Gold Star Families in a consistent manner either by contributing time and/or raising funds are given the title of Student Ambassador. These students take the message of bringing hope and Help to Gold Star Families to their schools and teammates. A Student Ambassador is given increased opportunities to serve our Gold Star Families directly and also given freedom to lead their co-workers in ways to help fundraise or bring awareness to the high costs of their every opportunity and freedom.
